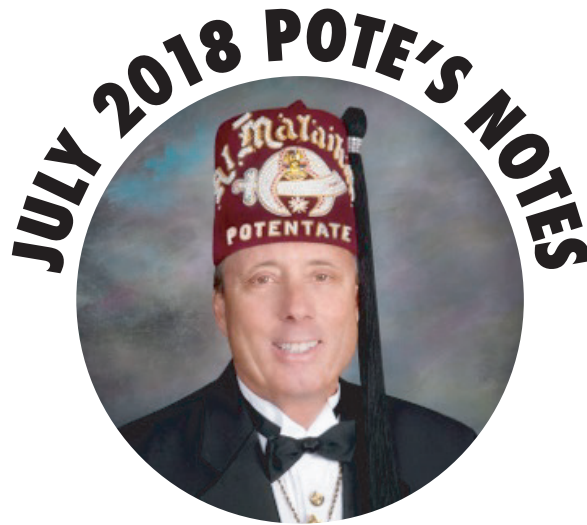

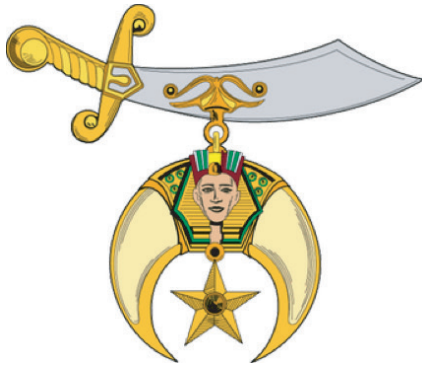

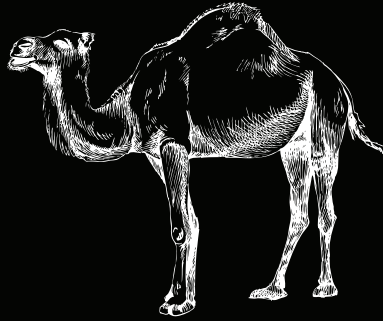

Shriners Hospitals for Children®

Dear Fellow Nobles,

Shriners Hospitals for Children has responded to a need to help children in the crisis in Guatemala. An emergency medical team left from Galveston Shriners Hospital within 24 hours of the volcanic eruption in Guatemala.

We are currently working with U.S. Southern Command and other military commands, including the Army and Air Force; the Guatemalan Embassy; the U.S. Embassy; the U.S. Department of Health & Human Services and the Department of State. We have arranged for these children to be transported today. According to the most recent briefing I have received, the flight team is expected to be wheels up to Guatemala at 3:15 p.m. CT today.

Today is a critical day for executing the airlift plan. There are a lot of moving parts that all have to align for this transportation to occur. However, we have had tremendous cooperation from the U.S. military and government as well as the Guatemalan military and government.

Staff and volunteer Shriners have been working around the clock to make this medical airlift a success. Thank you to all the Shriners in Guatemala for their efforts in paving the way to get necessary government approvals and documents and for their work in making this successful. They also helped the go-team navigate to various hospitals where the children were being treated and assisted in moving the children to a centralized hospital in order to stage the transportation by military.

I also want to thank the Galveston Shriners Hospital team, the Headquarters team and the go-team for making this come together. Additionally, I have been very impressed with the professionalism and dedication of both the U.S. Southern Command and other military commands during this humanitarian mission.

We anticipate receiving six (6) patients at Galveston Shriners Hospital shortly after midnight (CT) tonight. We will continue to keep you posted as we provide this life-saving care to these kids.

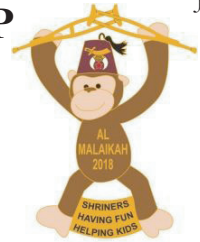
