The Mystery of the Donor Box for Shriners Hospitals Article and Photos by Noble Bruce Rick

The Four Seasons Resort Biltmore in Santa Barbara has been sending a donation check to Shriners Hospitals for Children Los Angeles about once a year for at least 35 years, but no paperwork indicated from whom or why. Al Malaikah Nobles Aaron Hanson and Bruce Rick undertook the solving of this mystery.

Noble Hanson is the Director of Development for Shriners for Children Medical Center in Pasadena, California, and Noble Rick is the Secretary of the Santa Barbara, California Shrine Club and an Emeritus Member of the Board of Governors of the Shriners Hospitals for Children-Los Angeles.

The first part of the story started with a person trying to put money in the donation box attached to the pedestal of a Buddha statue with an “in memory of” plaque, but the box was full. The statue is located just off the lobby of the Four Seasons in Santa Barbara and has a plaque requesting donations “in the memory of Noble and Mrs. David H. Chambers.”

The lobby receptionist did not know who was responsible for the collection and recommended contacting the Shriners Hospitals.

After some time getting to his desk and then not finding many Chambers family donor records, Director of Development Hanson in Pasadena contacted Secretary Rick in Santa Barbara for help in locating the donor family and donation box gift plan.



Member record checks from the Santa Barbara Shrine Club, Al Malaikah Shriners, and even the Grand Lodge of California failed to identify Mr. Chambers as a California brother.

The Santa Barbara Shrine Club adopted a resolution to take responsibility for the donation box in behalf of the Shriners Hospitals for Children. Before the time came to have a small ceremony with a changing of the lock, the Four Seasons management discovered that their accounting department had the donation box responsibility and the key.

Also in this time period, Director Hanson discovered a donation record for the Four Seasons Hotel in Santa Barbara, but with no information other than the check name. A records check back to 1994 showed a total over \$12,000.00 had been given in relatively small amounts, about annually, to the Los Angeles Shriners Hospital. However, there had been no recent donation. L-R Noble Hanson, Noble Rick\ Noble Hanson and Noble Rick met Director of Security George Aguilar at the Four Seasons to show the Fez and talk about donations to the Shriners Hospitals for Children.

Mr. Aguilar told them of the tremendous damage caused by the Montecito mudslides and the resulting closure of the Four Seasons for over 6 months. With the reopening of the Resort, there had been turnover of accounting personnel, and the donation box had been forgotten. However, the accounting procedure was found and the key was given to Mr. Aguilar for the meeting with Nobles Hanson and Rick. The donation box was opened and small bills stuffed the box. Mr. Aguilar gave assurance that the donation process would start again that day.

Although the Santa Barbara Four Seasons donation cycle has been documented, the mystery continues as to when and who built the statue and made the plaque, and who were Noble and Mrs. David H.
