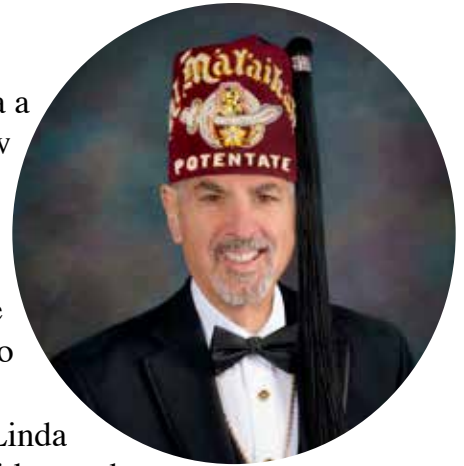

It is my pleasure to invite you to join us next year for what will be Al Malaikah Shrine's 38th consecutive trip to the largest single sporting event in the world, the Indianapolis 500 Race! Next year will be the 103rd year for the race, and it promises to be an outstanding event. We will leave on an early flight Wednesday, May 22nd, and return on Monday, May 27th.

The trip package as planned includes the following:

- Round trip airfare from LAX
- All ground transportation in Indianapolis
- Five (5) nights housing at the newly upgraded Holiday Inn Indianapolis-Carmel including a full hot breakfast buffet daily
- Gasoline Alley Tours, and Race Day tickets (great seats on the outside of the first turn)
- Factory tour of the Dallara Indy Car Co.; plus, we are working on additional activities & tours
- All dinners
- Barbeque dinner with Murat Temple's Potentate, Divan, Past Potentates, and the Imperial Potentate
- Parade seats and continental breakfast on Saturday
- Race day breakfast, box lunch, and police escorted bus transportation to the track
- All refreshments (alcohol, drinks, and snacks) in our personal Hospitality Room at the hotel

At this time, it is too early to finalize the exact cost; however, we estimate the cost to come in at about \$2000.00\*. As in previous years, this is a Revenue Neutral Activity. Any funds left over after expenses will be refunded to the participants; or, **donated to the Shriners for Children Medical Center in Pasadena, by request.** IMPORTANT: if there is a shortage, all participants will be billed the difference.

***\*This year we are adding the option to pay by Credit Card. However, since this is a Revenue Neutral Trip, if you would like to pay by Credit Card, then an additional charge of \$73.00 (\$36.50 per each \$1000.00 charge) will be accessed to cover the charge taken by our Credit Card Processing System.***

## Every Noble needs a Living Trust to protect himself, his loved ones and his hard-earned assets. Why?

### To Ensure:

- That when you pass away, your assets go to the people you want without expensive court interference and unnecessary legal fees
- Your spouse is properly cared for after your passing or during your disability
- Your children's inheritance is protected from divorcing spouses
- Your grandchildren are protected from those who would take advantage of their inheritance
