The fact that we are now in a full-service hospital building gives us the opportunity to provide more complex care in this facility and allow the patients and families from the Tijuana area to get superb care as close to their homes as possible! Shriners Hospitals for Children Ambulatory Clinic — Tijuana, previously known as "La Casita," is a specialty ambulatory clinic providing comprehensive medical and surgical care to children up to age 18 with orthopaedic conditions, burn scars, and cleft lip and palate. Patients receive all services in a family-centered environment, regardless of the families' ability to pay.

The first Tijuana outreach clinic was held on June 6, 1998, at Hospital de las California – Tijuana, where over 360 children were seen. Thanks to the collaboration of the physicians and staff, this Tijuana outreach clinic was conducted six times a year (one-day clinics), with approximately 200 children being seen each time. The outreach clinics continued at HIC until 2012.
